### **How Can You and Others Contribute?**

❖ **Direct Fund Donations:**

Individuals wanting to share in this ministry with a direct donation can complete the attached form and enclose a check made out to IHMCS. Funds will be used as needed to address the financial needs of families/students requiring assistance.

❖ **Become an Angel to a Student:**

Invest in one child's education and one family's dream. As an angel, you commit to a minimum of \$500 for the year. Although you remain anonymous, the student you are assisting will know of you and send an angel card to you. ❖ **Memorials:**

A memorial is a rewarding way to celebrate the life of a loved one. If you wish to contribute to the fund through the gift of a memorial, please contact the business administrator at (952) 935-1432 and arrangements will be facilitated.

❖ **IHMCS Home and School Fundraising:**

Each year the IHMCS Home and School parent organization facilitates a number of fundraising events. Approximately 10-15% of all funds raised from these events are funneled into the Scholarship Fund. By attending and participating in these events, you are contributing!

❖ **Other:**

Affiliated service organizations of IHM parish or IHMCS may adopt the Fund as the beneficiary of their efforts and goodwill. Funds contributed will be used to address the needs of those families requiring assistance.

### **How Are the Funds Distributed?**

IHMCS participates in a service provided by PSAS (Private School Aid Service). PSAS provides relevant aid determination information to the IHMCS principal for those families, regardless of parish, requesting assistance. Distributions are limited each year to the money within the fund. Any monies not utilized during the school year stay within the fund and are available for use in the subsequent year.
